Wednesday	November 4	NWEA conference sessions begin and conclude at noon on Thursday the 5 th

Tuesday and Wednesday there will be showcase opportunities during several breaks, and events are scheduled in the exhibit hall to promote traffic from 1:30–6:00 p.m. As always, the Social Hour takes place both evenings in the exhibit hall from approximately 5:00 – 6:00 p.m. Other activities include Top Ops and Water Tasting competitions.

VENDOR EXTRAVAGANZA! We are asking all exhibitors/vendors to bring a gift item of at least \$50.00 value. Attendees of the Conference will be required to visit your Booth Wednesday from 1:30-4:00 p.m. to be eligible for the raffle of the 'NWEA Vendor Extravaganza' gift items. Electricity is provided to exhibitors/vendors with an available 110 volt and 10-amp service. Free Wi-Fi is provided to all exhibitors/vendors and guests of the Conference.

The exhibit hall will be available to set up after 2:00 p.m. until 7:00 p.m. on Monday, November 2nd. Additional set up time will be from approximately 6:30–8:00 a.m. on Tuesday, November 3rd. Booths must remain in the exhibit hall until 6 p.m. Wednesday, November 4th. Teardown may begin Wednesday, November 4th after the Social Hour (at approximately 6:00 p.m.).

Outdoor Equipment Exhibits set up will be on November 2nd, between 12:00 p.m. and 2:00 p.m. Times will be assigned after all registrations are received to help coordinate that larger equipment arrival.

You are permitted to have **two (2)** additional name badges with a single booth registration and **four (4)** additional name badges with a double booth registration for those attending as support for your organization's booth. These are NOT registrations for the conference. You will have the chance to add these to your online registration.
